

3. Time zone

The official schedule throughout the territory of the Republic of Paraguay in the UTC-3 time zones for daylight saving time and from March 24, 2024, (winter time) with respect to Coordinated Universal Time (UTC-4).

4. Weather information and dress code (August)

In August, the average temperatures would be between 14.0°C and 25.0°C, with exceptional possible peaks as low as 0°C and high as 38°C as observed in previous years. It is recommended to visit the Meteorology Directorate (http://www.meteorologia.gov.py/) before starting your trip.

10. Requirements for passport, visa and vaccines

<u>Foreigners with Transitional Stay (Non Residents).</u>

1. Valid passport, or current identity document of the country of origin (valid to travel in MERCOSUR for citizens of the States parties to it) for entry and exit from the country.

2. Visa Consular or Arribo, provided by the Ministry of Foreign Affairs (in cases where a visa is required to enter Paraguay) only for entry into the country.

Health requirements for entry to Paraguay

<u>Yellow fever vaccine</u>. (Mandatory for travelers from risk areas Brazil, Bolivia, Peru and Venezuela) and recommended by travelers from other countries. By Resolution SG No. 040/2022, the Ministry of Health establishes that any traveller, national or foreign, who comes from risk areas: Brazil, Bolivia, Peru and Venezuela must be vaccinated against Yellow Fever and have the International Vaccination Certificate to prove it.

The presentation of the International Certificate of Vaccination against Yellow Fever may be required by the personnel of the transport company at the time of the purchase of the ticket or by officials of the surveillance area of the Ministry of Health before carrying out the migration procedures.

Persons who for health-related reasons cannot receive vaccination must justify their situation by means of a certificate issued by a registered medical professional authorised by the Ministry of Public Health or by the health authority of the country of origin and comply with the health monitoring and control for a period of ten days from their admission.

COVID vaccine.

Since October 24, 2022, the protocol of entry to the country of 02/06/22 has been invalid, so the presentation of the COVID-19 vaccination card or the RT-PCR test for entry to Paraguay is no longer required. 11. Medical Insurance

Participants must enjoy good health and have a measured insurance or other type of health coverage to deal with cases of illness or medical emergency that may arise, since neither the EASA nor the

DINAC of the Paraguayan Government are responsible for possible medical expenses incurred by a participant.

12. Currency and credit cards

The national currency is Guaraní (G). The exchange rate is subject to the change of the day ranging from 7290,19 to 7500 Guarani for each dollar (USD). 13. Safety recommendations

19. Attractions to visit in the city of Asunción and the metropolitan area

Asunción is the capital and the most populous city in the Republic of Paraguay. It is an autonomous municipality administered as a capital district and is not formally integrated into any department. It is located in the center-west of the Eastern Region of the country, bordering to the north with the Paraguay River that separates it from the department of Presidente Hayes, and in turn from the

Western Region; to the south and east with the Central Department and to the west with the Paraguay River, near the Pilcomayo River, which separates it from the Argentine Republic. Founded on August 15, 1537, it is one of the oldest cities in South America.

With 521.091 inhabitants in 2023, it is the most populated and urban city in the country. While its metropolitan region, called Gran Asunción, increases its population to almost 2.343.908 inhabitants, thus making it one of the 20 largest urban agglomerations in South America. Its surface area is 117 km² in the city, and 2.582 km² the Great Asunción.

Asunción is the seat of the three branches of the nation (Executive, Legislative and Judicial), and the main river port (Directorate General of Customs), also constitutes the cultural center of the country. Despite some variations in the course of time, from its foundation to the present, Asunción is the center of national activity. The capital gives the main resolutions and projects of the powers of the State, and centralises the banking, the economic, cultural, diplomatic, social, trade unions and industrial entities of the country. From Asunción they teach most of the main routes of the country, to the main cities of the country.

Asunción is considered a global city of category "gamma -". The city is among the cheapest capitals in the world, and lately as one of the best cities for investment, both construction and services. It also has varied services of gastronomy, hotels and shops of first level, retaining until today most of its historic buildings, combined with wide and wooded avenues that have the largest infrastructure of shopping centers, bars, cinemas, casinos, theaters and leisure places within the city. It is recommended to wear sunscreen, caps, comfortable shoes such as sandals, sports shoes (tennis), fresh clothing and mosquito repellent.
